The Rental Group understands the purpose, objectives and Doctrinal Basis as outlined in Beacon's "Who We Are ?" brochure and understands that the use of Beacon Bible Camp must be in agreement with the guidelines given and that the Rental Group teach and uphold these truths as set forth in the Doctrinal Basis.
4. In the event of illness or accident or misfortune, the Rental Group recognizes that Beacon Bible Camp, its Directors or staff members are not liable or obligated to pay for any dentist, doctor or hospital services, X-rays, drugs or other related services where illness or accident or misfortune is caused by the negligence of the Rental Group.
5. The Rental Group agrees to call the Beacon office two days prior to their arrival at camp with the final number of persons in their group so that proper preparations can be made at camp.
6. The Rental Group accepts the BBC Rules of Conduct and agrees to adhere to them while at Beacon Bible Camp.
7. A deposit of \$250 is required to secure the reservation date.
8. Beacon reserves the right to retain the deposit upon cancellation of a rental less than 30 days prior to the reservation date.
